Terms and Condition for riding Off-road Trailbikes with Algarve Trailriding Tours

(Sandytoes Algarve Lda Unipessoal)

By signing this statement you agree to the terms and conditions as written here. Off-road Trailriding can be a dangerous activity. Whilst every effort is made to minimise any chance of injury ATT/Sandytoes Algarve will not be held responsible for any accident or injury that may result from participation in a Trailriding Motorbike experience.

You declare you are in a state of good general health do not suffer from any medical condition that may cause you to be a danger to either yourself or any other participant on a Trailriding Tour. If you have the need to wear glasses or use contact lenses etc for corrective eye measures or need medication for your eyes, you have taken all the steps necessary prior to riding on a Tour.

You must declare prior to riding to the guide if you suffer from any medical condition/allergy/need specific medication in the case of a serious accident. This may help emergency services/medical staff etc.

You have a full motorbike license and it must be carried with you at all times during a Tour.

Minimum age for a Tour is 21 years old.

You are not riding under the influence of alcohol, illegal substances or medication that may have an impact on your ability to ride a motorbike. ATT has a ZERO tolerance policy towards drinking and driving. We reserve the right to refuse riding if we suspect you of being intoxicated/stoned furthermore no refund will be given in this case.

You agree to ride in a responsible manner at all times using common sense at all times.

Never overtake the guide during normal riding activity, never ride beyond your ability and show due care and attention at all times. You may be riding on standard roads and classified byways as well as offroad sections. Always slow down for any animals or stop if necessary. Walkers, cyclists and road vehicles use some of the trails so care and attention to be paid to these users as well, slowing down or stopping if necessary also.

A 300€ safety deposit will be required to be paid in cash on the day of riding for the motorbike.

Clients seen riding in an inappropriate manner or negligent manner will be given a warning about their riding. If this persists the guide reserves the right to cancel the tour and no refund given.

Should any damage occur to the motorbike/equipment by riding carelessly and inappropriately all damages will be paid for by the client before they leave. Although we accept that minor damage to bikes and equipment will take place and as such ATT will make no charge in these cases for things like minor cosmetic damage/scratches. We do however reserve the right to charge for “significant” damage i.e broken plastics, radiators, levers, etc, etc, We will also charge for the full cost of repairs and loss of revenue in the event that the client wilfully refuses to behave or conduct themselves in a manner directed by the tour guide and as a consequence damage to equipment and or machinery is caused.

Whilst every effort is made to give you a safe and reliable motorbike we cannot guarantee there will be no failures/breakdowns with a mechanised piece of equipment. If it's possible to provide you with another/replacement bike we will endeavour to do so but this is not always guaranteed due to the small number of bikes in stock.

Personal accident cover is provided by us at Sandytoes Algarve (please ask us for a resume of what is covered) however it is highly recommended you carry your European Health card as well. A 30% deposit is required to confirm a reservation or booking. Should the client cancel a Tour at anytime before the reserved date NO RE-IMBURSEMENT will be made (unless proof can be provided of extenuating circumstances and is totally discretionary by ATT) . In the event of ATT cancelling a full refund will be given back.

You are responsible to pay any fines that are incurred for any rider related offences. i.e. speeding, road infractions, driving without due care and attention etc, etc. Sandytoes Algarve/The guide is not to be held responsible for any rider offence.
